Dear Home School Family:

BBCA offers a variety of extra-curricular activities to our Home School families. There are several forms included with this letter that you will need to fill out and return to the school office. We also require a \$100.00 registration fee, per family, that needs to be included with your completed paperwork. Once we have received your paperwork, we will set up a family interview, which is required for all new, incoming families.

We have included a *Health and Authorization for Medical Treatment* form and a *Health History* form. We need these completed in case your child is injured or becomes ill and medical treatment becomes necessary. Even if your child(ren) are only participating in band, choir, or end-of-the-year testing, we will need you to complete all forms. We also need a record of all immunizations in compliance with PHL section 2164.

If you are signing your child(ren) up to play sports, the Sports Insurance is optional. However, if you choose not to pay for it, your children are covered exclusively on your personal insurance. The *Health History* form includes a section that must be completed by your physician showing that your child has had a physical within the past 12 months.

Lastly, we have included a *Parent/Student Handbook* for you to review. Home School students are required to adhere to BBCA's policies & procedures, in order to be eligible to attend courses. **Please pay particular attention to the Dress Code section.** Once you have read over the Handbook, please sign the included form stating you have read and understand the policies, and return it with the rest of your paperwork.
